- i. La recherche en éducation technique et technologique: Un écosystème d'innovation et de transfert au bénéfice des processus sociaux et industriels.

Mechanisms for the management of applied and basic research in technical and technological education institutions represent a vector of integration with their environment, both on a social and an industrial scale. Combining a model of proximity with their ecosystem, the 59 College Technology Transfer Centers (CCTT) of Quebec's CEGEPs have been able to make a real contribution to the development and the social, technological and economic innovation of Quebec, while relying on a growing number of doctoral researchers to carry out these activities. This proposed panel, with the participation of the *Conseil supérieur de l'éducation du Québec* and the *Collège de Maisonneuve*, will provide a cross-examination of the research conducted in the Quebec CEGEPs as well as in other comparable institutions.

La alianza entre la universidad, el sector empresarial y el Estado, plantea un paradigma que propicia una misión emprendedora, al utilizar avances del conocimiento para el desarrollo socioeconómico de las regiones y del país. Esta colaboración es clave en el desarrollo regional. En el caso de la Universidad del Valle, se destaca la participación y la creación del CUEEV (Comité Universidad Empresa, Estado del Valle del Cauca) y la RUIV (Red de universidades para la innovación del Valle del Cauca), el aporte al establecimiento de la Política Pública en Ciencia, Tecnología e Innovación, la creación del CODECTI (Consejo Departamental de Ciencia Tecnología e Innovación); la articulación de las Agendas del Valle

del Cauca en CTel (Ciencia Tecnología Innovación); la convierten en un referente importante de esta tercera misión, a fin de identificar las prácticas investigativas para la transferencia del conocimiento y los limitantes existentes.

The Magna Charta Universitatum of 1988 set out values and responsibilities which have served well for 30 years. But the world has changed. It is faster, more global, more complex and stakeholders expect more and more various services from universities. Leading universities and determining their mission, values and operations is now much more challenging. The Magna Charta Observatory is currently producing a new Magna Charta Universitatum. It will address societal issues, sustainability and the responsibilities of universities to society through values that are relevant for the future. University College Cork UCC Ireland has been working with the National University of Colombia (UNal) to develop Capacity Building for Sustainable Universities and Campuses. Inspired by Green Campus developments in UCC, UNal created a task force to collaborate and share best practices and develop collaborative research and embedding sustainability into formal and non-formal curriculum. Workshops in Amazonia in 2017 and Cork in 2018 with community partners have developed collaborative research projects related to SDGs. Universidad Veracruzana (UV) in Mexico has joined forces through CoSustenta, an award winning Community Engagement program, to explore interdisciplinary approaches to exploring themes of sustainability at local, national and international level through research projects that include co-supervised postgraduate students. By sharing the Green Flag programme developed on UCC campus and now in operation globally, administered by FEE and UIGreen GreenMetric, we aim to inspire more HEIs to get involved.

West Virginia University (WVU) is a public, land-grant university situated in the heart of Appalachia, and holds the unique privilege and responsibility of helping to bring change and development to a region of the United States that has long encountered significant social and economic hurdles. In this context, the university has embarked in a systematic and innovative process of internationalization, that includes the creation of a new certificate in global competencies, the development of channels for faculty engagement, and the creation of global portals, among other initiatives. Successful innovation requires an environment that fosters a free flow of ideas among people with a wide array of experiences and perspectives.
