METHODS OF PAYMENT

All payments must be made in US Dollars (USD) using one of the following methods:

- 1. <u>Credit card</u>: CAEI accepts MasterCard and Visa credit cards. Complete credit card information must be provided at the moment of processing an online payment.
- 2. <u>Wire transfer</u>: Once the online registration has been completed, the system will forward a notification to the address provided. The registration will be considered "on hold" until proof of payment has been submitted and the reception of funds is confirmed.

To process a payment, each participant must:

- ✓ Follow the process outlined on the CAEI website,
- ✓ Provide all necessary information,
- ✓ Ensure that payment is made in US Dollars (USD).





Each participant is responsible for completing the payment process unless,

- ✓ A home institution or third party is processing payment on their behalf or
- \checkmark They participate as part of a group or delegation for which the registration fee is being covered by a coordinating organization or third-party institution.

Wire Transfer

Registered participants that choose to pay via wire transfer must provide proof of payment and provide a copy of a bank-issued document indicating the date of the transaction. Documents must be sent by email to caei@oui-iohe.org. Once the funds are confirmed, a final receipt will be sent by email in the name of the person or institution identified as the participant.
